Terms and Conditions for OPPO JIO CHEER CRICKET Scheme

Definitions

- 1. "RJIO" shall mean Reliance Jio Infocomm Limited.
- 2. "Scheme" shall mean the OPPO JIO Cheer Cricket Scheme made available by RJIO.
- 3. "Eligible Device" shall, subject to the terms and conditions provided below, mean any OPPO mobile device, purchased in India on or before June 18th, 2017.
- 4. "Eligible Subscriber" shall mean and include a person who has an Eligible Device and who is an active subscriber of the RJIO connection (existing or new) and is enrolled to the "Jio Prime" membership plan.
- 5. "Entitlement Period" shall mean a period starting from July 1st, 2017 (00:00 hrs.) and shall be valid for the period as per the entitlement provided in TABLE A: Entitlements Table.
- 6. "Recharge" shall mean a recharge performed of Rs. 309 or above.
- 7. "Scheme Period" shall mean the period starting from June 2nd, 2017 (00:00 hrs.) and ending on June 18th, 2017 midnight (both days inclusive).
- 8. "Selection Criteria" shall mean the criteria required to be met by Eligible Subscribers to avail Additional Data.
- 9. "Link" shall mean www.oppojiocheer.com
- 10. "URL" shall mean the unique shareable link generated upon successful login on the page of the Link by the Eligible Subscriber.
- 11. "Additional Data" shall mean such additional data credited to the Eligible Subscribers meeting the Selection Criteria, as per the entitlement stated in the following TABLE A: Entitlements Table:

How to participate in Scheme:

- 1. The Eligible Subscriber needs to send an SMS <OJ> to 59009 from his/her RJIO number active on the Eligible Device, during the Scheme Period. The SMS, so sent, shall be toll-free.
- 2. RJIO will, thereafter, send the Link by way of an SMS to the RJIO number from which the SMS from the Eligible Subscriber was received.
- 3. The Eligible Subscriber will then have to click on the Link and log-in with a combination of his/her Facebook ID and RJIO number.
- 4. Upon successful login, the URL will be generated which will be unique for each Eligible Subscriber.
- 5. The Eligible Subscriber may choose to share the URL on his/her Facebook, Twitter and WhatsApp accounts.
- 6. An Eligible Subscriber, who meets the selection criteria as provided in Table A: Entitlements Table shall be entitled to the relevant category of prizes as listed thereunder ("Winner"). The click on the URL counted for each Eligible Subscriber per platform will be one unique click ("Unique Click"). To illustrate, when a person clicks the URL 5 times from one account on either of the three platforms, the raw clicks are 5 but the Unique Click shall be only 1 since these clicks originate from the same account on that platform.
- 7. In the event of Eligible Subscribers achieving the same number of clicks for any category, RJIO may consider the time of registration to the Scheme (on first come first served basis) for determining entitlement to any category of prize. Any such decision taken by RJIO, on the entitlement of an Eligible Subscriber, shall be final and binding on such Eligible Subscriber.
- 8. Intimation of the prize to the Winner shall be made via appropriate means.

Benefits of the Scheme ("Scheme Benefits")

- 1. A Winner, who, during the subsistence of the Scheme, recharges his/her RJIO subscription, by availing the Recharge, shall be entitled to additional 4G data voucher ("Additional Data Voucher") as per the entitlement stated in TABLE A: Entitlements Table.
- 2. The Additional Data Voucher would be credited to the account of the Eligible Subscriber within 48 hours of Recharge.
- 3. Where a Winner gets an Additional Data Voucher under any category of Table A: Entitlements Table, the maximum number of recharges for such Eligible Subscribers shall be as specified against the said category.
- 4. In case of redeemed Additional Data Vouchers, the Scheme benefits, if any, that remain unutilized at the end of the Recharge cycle period, will expire and be forfeited.
- 5. Such Additional Data Vouchers that are not redeemed within the Entitlement Period shall expire and be forfeited.
- 6. An Eligible Subscriber shall be entitled for only such number of Additional Data Vouchers and the Scheme Benefits thereunder as corresponding with the number of Recharges the Eligible Subscriber performs within the Entitlement Period.

Terms and Conditions of the Scheme ("T&C")

- 1. The Scheme shall be open to all Eligible Subscribers on and from June 2nd, 2017.
- 2. The Scheme and the benefits thereunder are being offered by RJIO.
- 3. These T&C shall be read concomitantly with the terms and conditions of the Jio Prime membership plan and the CAF.

4. To activate the Additional Data Voucher and avail the Scheme, the Eligible Subscriber will have to download the MyJio Application on his/her Eligible Device and follow the steps specified below:

Open My Jio App -> My Vouchers -> View Voucher -> Recharge my number -> Confirm Recharge -> Successful Recharge Notification

Thereafter, the Additional Data Voucher shall be visible under the My Plans section.

- 5. Two or more offers cannot be clubbed together. This Scheme cannot be used in conjunction with any other alternative offer or promotion of a similar nature. However, the Eligible Subscriber will be entitled to avail the benefits under "Jio Dhan Dhana Dhan Offer", till such time that it is available.
- 6. The Scheme benefit can be availed only once on an Eligible Device or an RJIO number. Such Eligible Device or RJIO number cannot be used again for participation into the Scheme, with another RJIO number or Eligible Device as applicable.
- 7. If the Eligible Subscriber migrates from the Eligible Device to any other device, the Scheme Benefits shall be discontinued. Accordingly, RJIO shall record the IMEI number of the Eligible Device
- 8. RJIO recognizes that the choice to be contacted for promotional messages and alerts is that of the Eligible Subscriber. RJIO intends to keep the Eligible Subscriber informed on matters relating to the Scheme and any upcoming offers from RJIO for the benefit of the Eligible Subscriber. Accordingly, by availing the Scheme, the Eligible Subscriber hereby consents to be contacted by RJIO and such consent shall remain unaffected by and/or accordingly modify the Eligible Subscriber's registration in the National Do Not Call ("NDNC") registry under the relevant category stipulated therefor.
- 9. RJIO reserves the right to cancel/withdraw this Scheme at any time, without any prior intimation to the Eligible Subscriber. However, the benefits accrued to the Eligible Subscriber on or prior to the cancellation/withdrawal of this Scheme, shall not undergo any change.
- 10. RJIO, may, at its discretion, modify any of the terms and/or conditions and/or any aspect of the Scheme, without any prior intimation to the Eligible Subscriber. The modifications so carried out will be posted on www.jio.com.
- 11. If any term/ condition under the T&C of the Scheme is found to be invalid, void, or for any reason unenforceable, such term/condition shall be severed from the other terms and conditions and shall not affect the validity and enforceability of the remaining terms and conditions of the Scheme.
- 12. Any claims, issues, damages or losses with respect to the Eligible Device shall be the sole responsibility and liability of the manufacturer of the Eligible Device and RJIO (including its affiliates, group companies or parent company) hereby disclaims, any and all claims, losses and liabilities, whether or not arising out of, or in connection therewith and/ or this Scheme and the terms and conditions governing the Scheme. This disclaimer shall apply to the fullest extent permitted by law and shall survive cancellation/termination/determination of this Scheme.
- 13. In no event shall RJIO or its directors, officers, employees, agents or other representatives be responsible or liable for any direct, indirect, special, incidental, consequential, or punitive damages, or any other damages of any kind, arising out of or related to the Scheme.
- 14. The Scheme Benefits are non-transferable.
- 15. This Scheme is not a lottery.
- 16. No consideration is payable by the Eligible Subscriber for the purposes of participating in the Scheme.
- 17. This Scheme is subject to guidelines/directions issued by Telecom Regulatory Authority of India (TRAI), Department of Telecommunications (DOT) or any other statutory authority from time to time.

The Eligible Subscriber hereby authorizes RJIO to collect his/her personal information including name, address and mobile number and share with its partners so as to enable the Eligible Subscriber to avail the Scheme.
